






8. I think Y4 is a good time to start learning about physical changes during puberty. 13 responses







- On discussion with my husband, we are more than happy for the programme to be taught but are very mindful of the fact that our children are still innocent and I would ideally like to keep it that way for a while longer. I am more than happy for the correct terminology of body parts to be learnt but at this stage in our children's life (FS2 and Y3), we are still undecided if we want them to fully know about the journey of conception as it will bring up questions around it that don't need to be answered until they are a bit older. I appreciate that the programme is intended to be informative and educational but we would just like to be reassured that it will be delivered at an age appropriate level.
- Whilst I am happy with the majority of content provided regarding the Y3 lessons, I do not feel it is appropriate for XXXXX to learn about conception until she is older. I would like some clarification as to how this topic will be discussed and how in depth the classes will be. I personally feel it would be inappropriate for Y3 to learn about sexual intercourse as they are still so young. I understand this programme is designed to be educational and so I assume that the lessons will be delivered from a biological point of view, however I do feel that teaching the facts of conception will invite questions from the children about things they are too young to understand (sexual intercourse)
